Information about the rights of the person concerned

You, as the person practicing parental rights over a child (under the age of 18) whose data is being handled by our organization, have the right:

- a) to request access to your and your child's personal information from our organization
- b) to request supplement, correction, deletion or limitation of your or your child's personal data
- c) You have the right to data portability under conditions determined by law, and
- d) You may object to the processing of your and your child's personal information or
- e) Your data management consent may be withdrawn free of charge at any time. Withdrawal of your consent shall not affect the legitimacy of the data managed prior to the withdrawal of your consent. You may also initiate the withdrawal of your consent by post, or electronically at the amv@amv-marcali.hu E-mail Address.
- f) filing a complaint to the supervisory authority (National Data Protection and Information Authority, <http://naih.hu>, Phone number: +36 (1) 391-1400, postal address: 1530 Budapest, Pf .: 5, e-mail: ugyfelszolgalat@naih.hu). If you are a foreign national, you may also lodge a complaint with your supervisor at your usual place of residence or workplace.
- g) you may sue your court in case of violation of your or your child's rights. The court proceeds out of court. The processing of data protection claims falls within the jurisdiction of the court, the lawsuit may be initiated at the authorities of your own home or place of residence, according to you own choice.

In order to resolve the issue in due time, we kindly ask you to contact our Foundation before contacting an authority of supervisory or the court with your complaint.
